## **Curriculum Proposals-Nursing Application Change**

1. Associate in Arts: Film and Video Production

The FVP faculty propose the modification of their Capstone Project Course (FVP 2713). The program faculty have identified two courses (Screenwriting or Documentary Filmmaking) that provide the requisite knowledge and skills to enhance student success in their narrative or documentary capstone projects. To this end, the faculty propose the prerequisites for FVP 2713 should be changed to FVP 2273 or FVP 1713. To accomplish this, FVP 1713 has to be added to the curriculum as an alternative to FVP 2273 already in the certificate and the Associate in Arts.

Motion to approve course modification requiring student to take either FVP 2273 or FVP 1713 before they take their Capstone Project Course (FVP 2713) was made by Dr. Susan Tabor and seconded by Ms. Tammy Madden.

Other changes for AA in Film and Video Production: In order to distribute the general education course work more evenly, PHYS 1014 in the Sophomore first semester was swapped with General Education Elective in the Freshman second semester. An earlier curricular change to the Micro and Macro Economic series had not been addressed in the elective notes. The program faculty removed ECON 2113 because it is no longer offered as an AND OR, but kept ECON 2123 as the first level of that discipline.
