## **Election Day Voting Leave**

OCCC supports civic engagement by granting Eligible Employees paid time off for voting in local, state, and national elections, per Oklahoma law. Employees may receive up to two hours of paid voting leave if their schedules don't allow a three-hour window outside of work hours to vote. To qualify, employees should inform their supervisors by the day before the election and provide proof of voting. Supervisors will designate specific voting hours to ensure minimal disruption. Alternatively, OCCC may adjust work schedules on election days to provide a three-hour window outside of working hours.

- Secondhand smoke contains hundreds of toxic chemicals.
- Even brief contact with secondhand smoke can trigger a heart attack.
- Secondhand smoke can cause ear infections and asthma in children.
- In infants, secondhand smoke can cause death.

One vaping dose can contain as much nicotine as 20 regular cigarettes.

E-cig vapor may contain harmful chemicals and metals.

Vaping has been linked to cases of serious lung injury.
